## **GUIDELINES FOR THE AUTHORS**

- 1. Paper submitted to *The Critique of Law* should be formatted as follows: font *Times New Roman* 12 pkt, line spacing 1.5, alignment justified, page numeration;
- 2. Footnotes: font *Times New Roman* 9 pkt, line spacing 1, alignment justified, arabic numeration;
- 3. Footnotes should begin from capital letter and end with a dot;
- 4. Footnote numbers (upper indexes) should be placed directly after text (without a space) and before punctuation;
- 5. Bibliographic footnotes:
  - a. in case of a book: the initial name and surname of the author, title of the publication in italics, place and year of publication, page range, e.g. D. Bainbridge, *Intellectual Property*, Pearce, 2012, pp. 50–55;
  - b. in case of a collective work: title of publication in italics, the abbreviation "ed.", the initial and full last name of the editor (editors), place and year of publication, e.g. *The Sports Process. A Comparative and Developmental Approach*, red. Eric G. Dunning, Joseph A. Maguire i Robert E. Pearton, Champaign 1993;
  - c. in case of an article in a collective work: the initial name and surname of the author, title of the article in italics, [in:] title of the publication in italics, the abbreviation "ed.", the initial name and surname of the editor (editors), place and year of publication, e.g. A. Guttmann, *The Diffusion of Sports and the Problem of Cultural Imperialism*, [in:] *The Sports Process. A Comparative and Developmental Approach*, ed. Eric G. Dunning, Joseph A. Maguire i Robert E. Pearton, Champaign 1993, p. 132;
  - d. in case of an article in journal: the initial name and surname of the author, title of the article, title of the journal (full one) in italics, designation number and year, page range, e.g. M. Tsuchiya, *Defense against Cyber Terrorism: Head War and Body War*, "Transformations" 2010, 3–4/2010, p. 260;

## 6. Re-quoting:

- a. if the work is cited for the first time, a full description should be given;
- b. if the work has been already quoted:
  - and this is so far the only relied work of the author: the initial name and surname of the author, the abbreviation *op.cit.*, page numbers, e.g. D. Bainbridge, *op. cit.*, pp. 60–61;
  - and this is one of at least two appointed works of the author:: initial name and surname of the author, title beginning in italics ..., the abbreviation *op.cit.*, page numbers, e.g. D. Bainbridge, *Intellectual...*, *op.cit.*, p. 72;
- c. if the work was cited in a footnote directly preceding the current one: *Ibidem*, page numbers if they differ from those indicated in the previous footnote, e.g.
  - D. Bainbridge, *Intellectual Property*, Pearce, 2012, pp. 50–55. *Ibidem*, s. 48;
- d. if in a footnote followed by another, a work by the same author is cited, idem is given instead of the name of the author e.g.
  - D. Bainbridge, *Intellectual Property*, Pearce, 2012, pp. 50 55.

All cited publications should appear at the end of the article in the Bibliography (References) in alphabetical order by surname.
